I. Call to Order David

#### IV. Financial Report

## a) Expenditures, budget, past due accounts

Lisa

Major expenses for January:

- \$3,000 for 2015 taxes and financial review
- \$3,006 for Montevina Pipeline water usage
- \$595 for handyman work

There are currently six delinquent accounts (greater than 90 days past due) and the total amount due for these accounts is \$48,229.66. Of these accounts, three have water shut off and the other accounts are sending in some of the past-due amounts.

#### V. Water Report

# a) Water report

**Tyler** 

Total treated water production for February (29 days) was 1,362,300 gallons, up from 1,132,702 gallons in January (Moody and SJW combined). Average daily production was 46,976 gallons.

During February the raw water turbidity was stable except for a couple of rain events with modest runoff that shut the plant down. The raw water turbidity for water entering the plant ranged from 1.46 to 2.71 NTU. The average monthly finished NTU was 0.034 NTU (.330 NTU is the maximum turbidity allowed by the state). The plant ran at 47% of capacity.

Tyler received a call from a resident reporting a slide of mud and debris coming to rest against the back of the Los Gatos Creek redwood holding tank. It isn't dangerous, but will have to be removed when the rainy period passes.

Tyler set up a meeting with a representative from Aqua Tec to look at the redwood tank near the treatment plant. He will get an estimate for plugging the remaining leaks and schedule a work date.

#### b) State grant claim status

David / Dan

Have gathered all invoices that will be submitted to close out the grant and finalize the claim to get reimbursed.

# c) New well project, property merger

Control panel purchased for the new well project is not going to be needed, but it could be modified to handle the short well. Cost to revise the panel is \$3375. Will contact company and see about timelines.

#### VI. Roads

### a) Storm damage report

The repair work done on Comanche at Assiniboine appears to be working. Sandbags are doing the job.

The rock that was put on the bottom of Navajo is doing a good job.

Road issues on Comanche at Delaware; used some sandbags and put plastic down the hill, but plastic does not extend all of the way down to the creek. Will look at possible solutions. James made a motion to place a safety barrier along the edge of the slide to keep people away from the edge on Comanche at Delaware. Richard seconds the motion. Motion passed.
