Board of Directors Meeting, August 11, 2016

I. Call to Order David

II. Review and Adopt Minutes

David made a motion to approve the July minutes without changes. Dana seconds the motion. Motion approved. July minutes were approved.

III. Public Comment

Board

Members of the community are requesting an update on the grate at Assiniboine. Also some sandbags along the roadside have been damaged and we are looking at replacing them before the fall.

IV. Financial Report

a. Expenditures, budget, past due accounts

David

Major expenses for the month: \$1,267 for PG&E, \$9711 for insurance. No report on past due accounts this month.

b. Update on financial audit and taxes

Michael Murray

Michael Murray, C.P.A. brought in our Independent Auditors' Report. The report states that all materials reviewed and the financial position of the Organization (CPMWU) are in conformity with generally accepted accounting principles.

V. Water Report

a. Water report

Total treated water production for July (31 days) was 1,967,200 gallons. Average daily production for July was 63,458 gallons per day. The raw water turbidity for water entering the plant for July ranged from 1.20 to 1.60 NTU. The average monthly finished NTU was 0.041 NTU in July (.300 NTU is the maximum turbidity allowed by the state). The plant ran at 80% for 31 days of operation.

b. Aqua-Tech for tank sealing

c. Valve replacement program

d. Main pump project

Dan

Dan presented the estimate and proposed plan from Wy'east to upgrade pipes from the pump house to the tanks.

e. Old Well at Los Gatos Creek

Dar

Dan presented a quote to destroy the abandoned well at Los Gatos Creek, which is required by our Sanitation Survey. David made a motion to shift \$9,000 from the rollover fund into account 750, which is the Los Gatos Creek Source Fund and secondarily to allocate funds not to exceed \$10,000 to destroy the old well. Dan seconds the motion. Motion passed.

f. Cross connection control program

The Board has received many surveys for the Cross Connection Control Program water system survey, but we need to hear from all of you. This was sent in the June 26th bill (yellow paper). Please return this survey ASAP to the survey drop-off box or to the address listed on the survey. The Board is reviewing the program.

VI. Roads

a. Comanche / Delaware project status

Dan got a quote from Cotton Shires & Associates for a site survey and preliminary geotechnical evaluation. David made a motion last month to allocate not to exceed \$3000 for this proposal, however we need to allocate an additional \$2000 for the site survey in order to get a recommendation for repair. Dan made a motion to increase the allocation from \$3000 to \$5000. Lori seconds the motion. Motion passed.

b. Comanche / Assiniboine grate replacement

We need to repair a drainage culvert near the water plant. The Board is requesting a quote for this work. Also continuing talking with Mike Wasserman's aide to get assistance with pipe repair.
