Welcome to Chemeketa Park, a community of 140 households. We hope that you are enjoying your new home and the wonderful area we live in. We have compiled a resource guide to help you become familiar with Chemeketa Park, the services provided by our Mutual Water Company, trash and recycling schedules, fire prevention, electricity and propane, and much more. ### *CHEMEKETA PARK MUTUAL WATER COMPANY*



The Chemeketa Park Mutual Water Company was incorporated in 1929 as a nonprofit mutual benefit corporation. Its primary purpose is to operate a water system, roads, and recreational facilities for its members. The community funds the cost of providing these services through a bill that is sent each month by the Chemeketa Park Mutual Water Company. Services include treating and distributing drinking water to our residents, maintaining the roads throughout the community, and a recreational area. The Mutual

Water Company holds monthly meetings to oversee the operations of the water system, roads, and common areas. There is an Annual Meeting which is normally held on the first Sunday of June to discuss and vote on budgets and projects related to the water system and roads. Each property owner has one vote per each improved lot that they own.

Membership in the Company is attached to ownership of land within the boundaries of the Park. The members own the Company and have ultimate responsibility for the corporation and the services it provides. The Board of Directors oversees day-to-day operations in compliance with the by-laws. The Board consists of five directors and two alternates. The Board meets on the third Wednesday of each month at the Clubhouse at 7:00 p.m. Attending the monthly Board meetings provides the community with an open forum to become familiar with projects in process or being considered. In addition, we depend on community involvement to keep improving and enhancing our neighborhood.

Our water system is operated by Cypress Water Services. The Department of Health Services regulates the operation of the water system, including operator certification requirements, water quality monitoring requirements, and reporting requirements. If you encounter a water service emergency, contact Cypress Water at 831-920-6796 (24 hours).

Because our water source, Moody Creek, is affected by fluctuations in seasonal rainfall, we work together as a community and respond with water conservation measures when needed. One situation in which residents should be aware is during heavy rain events. During heavy rain, the water plant cannot process water due to the high turbidity in the creek. Therefore, during a rain event that lasts many days, the Water Company will ask all residents to please conserve water.

### *CLUBHOUSE AND PLAYGROUND*

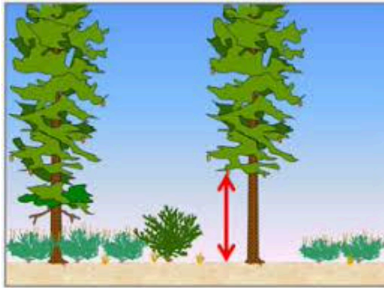

### *FIRE PREVENTION*

The beauty of the trees in the mountains is usually why we choose to live here. It is also very important to be fire safe while living here. We work together as a community to keep our park safe from fire. Here are a few things you can do right away:



- Keep all roofs clear of leaves and debris.
- Move your woodpile 30 ft. away from your house.
- Remove dead trees, brush and branches from your property on a regular basis.
- Remove all debris and flammable materials from under your deck.
- Install a reflective address sign in multiple locations on your property.
- Clear fuels to create space between the ground cover and the canopy.
- Keep combustible materials away from the foundation.

We have an Annual Chipping Program for all of our residents, sponsored by the Santa Clara County FireSafe Council. This program encourages each resident to clear a defensible space around their property and then the FireSafe Council disposes of the brush. Having a defensible space includes keeping each property clear of surface and ladder fuels which can cause fire to spread. Chemeketa Park is a nationally recognized Firewise Community within the Firewise USA group. This is a small team of community residents that have led, completed, and continue to work on a number of fire safety projects within the Park. The committee assists in reducing the risk of wildfire through education and participation in hazard mitigation. ### *Get involved with a POD*

Chemeketa Park started the POD program in 2019 with the purpose of helping each other in the case of an emergency, large or small. A POD is a group of about 10-14 homes with the function of being able to help each other out in case of wildfire evacuation or an earthquake. Helping each other in small “chunks” of a community has proven to be more effective and helpful in cases of evacuation or earthquake, as we learned from the Battalion Chiefs from both CalFire and Santa Clara County Fire Department. ### *SANTA CLARA COUNTY SHERIFF*

The Santa Clara County Sheriff is the responding department for police emergencies. If you have an emergency, dial **9-1-1**.

### *SANTA CLARA COUNTY*

Contact Santa Clara County at [www.sccgov.org](http://www.sccgov.org) if you have questions about what can and cannot be done with your property. Santa Clara County, not the Chemeketa Park Mutual Water Company, governs land use ordinances in Chemeketa Park, such as single-family zoning (how many dwelling units per acre/parcel are allowed in Chemeketa Park), restrictions on cutting trees in Chemeketa Park, and noise (barking dogs, hours and days in which commercial power tools can be used in construction, and hours music can be played at a volume audible by neighbors).

### *HISTORY*



Chemeketa Park was developed in 1925 by J.B. Balcomb, a civil engineer from Palo Alto, who acquired a 63-acre orchard

in the Santa Cruz Mountains. An advertisement in the Sunday, June 20, 1926 edition of the San Jose Mercury Herald lists a "pre-opening sale" for lots "as low as \$50.00."

Initially, lots were used for vacation cabins. The mountain communities of Chemeketa Park and Redwood Estates were considered too remote and too difficult to access for year-round living. Lots were advertised to Bay Area families as a summer retreat, far from the stress of city living in San Francisco and San Jose.

By the mid-1930's, with the improvement of roads and water systems, many residents began occupying their cabins year-round and combining smaller lots into larger parcels.

Chemeketa is a Kalapuya Indian word with various meanings attributed to it, including "resting place", "meeting place", "old home", or "old camping ground". The Kalapuya lived in the area now known as Salem, Oregon. Chemeketa was an original name of Salem and still exists as the name of a community college, a library, and various parks and streets in the Salem and Portland areas.

When J. B. Balcomb and his wife moved from the Midwest to California, they first stopped through eastern Oregon where they most likely heard the name "Chemeketa". The Native American theme is present throughout Chemeketa Park with street names like "Comanche Trail", "Ogallala Warpath", "Apache Trail", and "Navajo Trail".

We are happy to have you join our community! We hope to see you at the Clubhouse for our community get-togethers where you can meet your neighbors. We rely on each other to keep our community safe and free from fire hazards.

You are welcome and encouraged to join our monthly Board Meetings to get to know what is happening within the park. Board Meetings are held the third Wednesday of each month at 7:00 p.m. at the Clubhouse. Look at the Chemeketa Park Mutual Water Company section above for more information.
